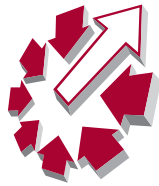

4th RECYCLED PACKAGING for FOOD CONTACT

24-25 MAY 2023
PORTO, PORTUGAL



From 11 July 2023, materials made from recycled plastics as a result of an “unsuitable” recycling technology will no longer be allowed to be placed in the EU market.

The EU Commission’s new regulations on using recycled content in contact with food (Regulation 2022/1616) will bring experts in the field to dive deeper into these regulations and the impact it will have on the packaging sector.
